

CONTINUING OUR WALK TOGETHER: THE THIRD SYNOD GENERAL SESSION

On Saturday January 20, 2018, St. John XXIII Parish once again hosted the Archdiocesan Synod for the third of its General Sessions. About 160 delegates gathered to pursue our mission: to discern the "signs of the times" and the movements of the Holy Spirit in the Archdiocese and, eventually, to offer Archbishop Gagnon our best advice.

As you may recall from our last report, in December the Synod completed its initial consideration of the proposals of the seven Focus Commissions. Since that session, the Secretariat (a group charged with managing the Synod and with collating and sifting delegates' various comments on proposals) has been considering amendments proposed by delegates. In our January General Session, the Synod looked at the Secretariat's proposed amendments and additional proposals, discussed them and voted upon them. As in the past, delegates who have concerns about this or that amended or new proposal have been invited to submit commentary to the Secretariat.

As we have reported to you, this synodal process is not like some public opinion poll. Delegates' votes are not based on their personal opinions and are not tallied like a parliamentary vote. Rather, delegates are called to listen to one another and to the Faithful in our various parishes and, most importantly, to the promptings of the Holy Spirit and to cast our votes according to the best interests of the whole archdiocesan church and not just by our own opinions. To give our fellow Brebeufians a sense of what this process is like, we will share an example of one amended proposal.

At the Synod's first General Session, we considered the following proposal from the Focus Commission on Marriage and the Family: "The archdiocese affirms as a priority that we educate clergy, seminarians and pastoral workers on recognizing and ministering to 'irregular/unconventional/alternative' family situations." This particular proposal, according to the Secretariat, received the most email commentary among all the proposals. The Secretariat considered all the comments and proposed the following amended proposal: "Our parishes seek to respond in love and in fidelity to the church's teaching to the various forms of family life present in our communities."

Now, in a secular debate, there would be a back-and-forth, a challenge of views contrary to one's own and a show-down vote. This is not at all what happened in our third General Session. Rather, various groups of delegates quietly discussed the proposed amendment. For example, in one group, much was made of how in the proposed amendment, the obligation to reach out in charity falls not upon the clergy but, rather, upon the parish communities, noting how the emphasis now was upon a *change of heart* rather than upon a *change of mind*. And in the phase of asking the Secretariat for clarification, it became clear that some delegates were concerned about the phrase "in fidelity to the church's teaching," reasoning that ALL proposals are presumed to be so.

At this point, Archbishop Gagnon, the presider over the Synod, made what is (so far) his only intervention into the formal process. The Archbishop noted that our Christian response must always be from *love* but also from *truth*. This response seemed very welcomed by the Synod. Delegates then voted by a large majority to support the amended proposal, though delegates can still offer to the Secretariat their ideas for improvement of the phrasing.

The Synod is scheduled for several more General Sessions. The work of these sessions will be to prioritize the proposals. In his concluding remarks to the January session, the Archbishop compared the upcoming process to that of funneling. The Synod's mission will be to discern what is essential in the proposals, to distill them and hone them into a plan for action. In the meantime, please continue to pray for the Synod and for its work.

Fourth Sunday in Ordinary Time: Deuteronomy 18:15-20; Psalm 95; 1 Corinthians 7:32-35; Mark 1:21-28

In 1899, Victor Records adapted a painting by English artist Francis Barraud for its logo. The seated dog listening attentively to a phonograph became one of the most recognized images of the 20th century. Francis' inspiration for the painting, so the story goes, was his brother's dog, Nipper. His brother, Mark, had died four years earlier. He left Nipper in Francis' care, as well as a cylinder phonograph. When Francis played some wax cylinder recordings of his deceased brother, he noticed that Nipper cocked his head in curiosity at the sound of his late master's voice. Francis' painting of the scene was perfect for selling the new technology; it implied that the phonograph reproduced sound so authentically it could even trick the sensitive ear of a dog.

The story of Jesus preaching in the synagogue features a moment of recognition too. The people were astounded at his teaching, for he taught as one having authority. They were listening directly to the Lord's voice, and it stirred something within them to stop and pay attention. Jesus also piqued the interest of an unclean spirit. The voice of the demon was fractured and anxious. It referred to itself as "us" and worried about its own destruction. In contrast, Christ was wholly attuned to God, speaking clearly together as one voice. Even the unclean spirit recognized, "the Holy One of God." Jesus silenced the confusing and accusative voices of the demon with a voice unified with God.

Our own spiritual lives are marked by a chorus of voices competing for our attention. Some voices are easily dismissed—they drip with disdain, greed, envy, or pride. Other voices are less obviously harmful. They speak to us in the guise of virtue, but seek to steer us gently away from God's one true call: self-doubt falsely dressed up as humility, or paralyzing anxiety under the façade of prudence. How do we recognize the way forward? Imagine poor Nipper surrounded by many phonographs each playing some recreation of his master's call. To pierce through such cacophony, God speaks to us with a voice we recognize, so we turn to follow the Lord. We don't have to settle for mere reproductions, our Master speaks to us with one true voice.
