**From the desk of Fr. Rob.....**

As we prepare to begin the Season of Lent on Wednesday, our Gospel gives us one last opportunity to ponder on the words of Jesus in the Sermon on the Mount. In it, Jesus lays out the moral teaching of the Kingdom. He continues to invite us to broaden our understanding of discipleship and to commit fully to living our lives in a radical way -totally dependent on grace and trusting in the guidance of the Holy Spirit to help us along the way. The Gospel today is a great springboard for Lent as it encourages us to strive for holiness. Matthew's understanding of perfection is not about our "not making mistakes" but rather, striving to be holy, as God is holy. Our baptismal grace calls us to a life of holiness which is witnessed to by how we love one another even when it is difficult. As we begin the season of conversion, may we embrace the call to leave behind what drags us down and strive always to shine with the light of Christ.

I was a week ahead of myself with the note about Reconciliation last Sunday. The children are celebrating their First Reconciliation this week. All are welcome to join us and jump start the season of conversion with an experience of mercy.

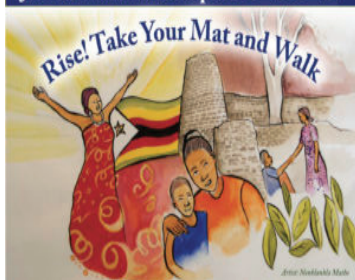
