Dear Friends:

I wish to provide you with an update of the sale of (St. Williams) Emeryville Site. On Tuesday, August 9th a meeting was held at the Town of Lakeshore regarding the Official Plan Amendment & Zoning By-Law Amendment regarding the repurpose & proposed use of the church & rectory buildings by the new purchaser, LAFA (Lakeshore Academy of Fine Arts).

At the meeting the motion to approve the rezoning and official plan amendment was approved unanimously. As I understand there is now the 20 day appeal period and then the County must approve which will likely be 30 to 60 days.

We have already received approval from the Lakeshore Committee of Adjustment by way of a consent approval for the access to St. Williams Cemetery through a permanent easement to the lands.

It now appears that everything is in order to finalize the sale of St. Williams Church & Rectory. Therefore, we will be moving forward with closing of the Parish Office at the Emeryville Site effective September 1st.

Once the transaction has closed, LAFA has agreed to allow us to use the church space on Sundays to hold our regular 9 am and 11 am masses as well as Masses at Christmas and Easter until such time as we are ready to move into our new place of worship and facility on Advance Blvd. You will notice some changes in the sanctuary in the coming months but LAFA has worked with us every step of the way and will allow our statues/stations of the cross to remain with some minor changes to the altar furnishings. I have to tell you that LAFA have been great to work with and always concerned to help make this transition as easy as possible. They are very excited to be in our community.

At the end of the school year in late June I met with the new Principle and Vice Principle of St. William's School and at the end of September 2016 we will begin having our Wednesday morning masses in the School Library. Each Wednesday there will be a class or two present at these masses and parishioners are welcome and encouraged to attend. We felt it was important to continue this mass when we can. We will work with the school and publish in the weekly bulletin when the masses will be held. We will of course not be able to have the masses during Christmas holidays and the summer months. I thank the principle and staff for working with us to make this happen.

There has also been a lot of activity at the Tecumseh Site. We are finalizing the work needed to be done on to sever the Rectory from the Church property. At the time the Rectory was built all the services were connected to the Church, and so for the last three weeks work has been done to connect all services to St. Gregory Road. The work is almost complete. The Church property is still under contract and negotiations continue. I will keep you posted.

Change is always difficult and I hope you know we are trying to do everything possible to make this transition as smooth as possible. I thank you for your support and prayers as we build for our future. **Father Gary**
