Ruminations

It will be the tenth anniversary on Tuesday of the operation I had on my spine at Sunnybrook hospital. It was quite the whirlwind adventure that led up to my first encounter with a stay in the hospital. My only other encounter was when I broke a knuckle and the great emergency doctor crafted a cast that allowed me to continue to play hockey though my slap shot was severely hampered, much to the joy of the opposition goalies. It all started with my inability to walk in a straight line. I would tend to the left and it was a real struggle to counteract it. Then all my stamina was gone. I would walk from the rectory to the church and then jog home. It was about three kilometers and it was nothing after a while. Then I couldn't walk more than a couple hundred meters without gasping. Then a tingling numbness set in, starting down my right arm, then right leg, and then the left side of the body. At first I thought it might be a cramped muscle and so I was off to the massage therapist. Believe me, it doesn't take much of an excuse to get me to make an appointment for that. It seemed to have no effect so I went to the chiropractor. Again, there was no great resolution. Finally I went to see my doctor. He has some suspicions and so it was arranged that I would go for a couple of MRI's. It was scheduled for a couple of months down the road, but he was not satisfied with that and within a couple of days I had the two of them scheduled for the up-coming Thursday and Saturday. I have to admit that the first MRI was absolutely traumatizing. I was expecting a 30 second procedure and it was a 20 minute torture with my shoulders crammed into tube and the warning not to move. I literally in shock all the way home and swore I was not going back for the second one on the Saturday. Well, I talked myself into going, but knowing now what to expect, I prepared myself and although it was about 30 minutes, I left there content and now waiting the 7 - 10 days for the results. On the Monday, I got a call from my doctor who invited, no who ordered me into his office later that day. He had acquired the results already and had me in to send me to a neurologist at Sunnybrook for that Thursday. At that appointment, the doctor wanted to admit me through emergency but I protested - I had a couple of weddings coming up, not to mention Sunday masses. Besides, I felt like I was getting better though he explained that I'm not getting better, I am adapting. He warned me vociferously to take it absolutely careful and there was a high risk of paralysis. Well, most of the symptoms disappeared after the operation, but there is still some residual numbness in the right side that affects the important functions like shooting hoops with the kids, or skating, alas. It also affects my balance so after two falls down stairs and one fall up stairs, and several tumbles



out walking, I am extremely cautious going down steps. To celebrate I bought a gold chain that sort of hides the miniscule, almost invisible scar that is a reminder of that August morning ten years ago this week. But the best thing by far was the anesthetist, who when prepping me to go under, remarked at how small my mouth was. I asked him for that in writing as I was counting backwards. He never provided me with that document and to this day, people do not believe him. *Fr. Roy*

Masks are Mandatory


The newest By-law in York Region came into effect on Friday, July 17, mandatory that masks must be worn in public places in-doors. For us, that means that all in the congregation must wear masks during the celebration from the moment they enter the building until the exit the building. Provision is made for the reception of Communion., for lecturing, and for presiding. There are a few exemptions for those with respiratory issues but the expectation because of their fragile health system is that they would not be present anyway.
